# Uganda on the road to Elimination of River Blindness/Onchocerciasis

Transmission has been interrupted in ten out of the 17 foci, protecting a population of more than 2.7 million people.

Uganda has zeroed on its goal of eliminating Blindness (Onchocerciasis) nationwide by 2020. The 8th Uganda Onchocerciasis Elimination Expert Advisory Committee (UOEEAC), which met from 3-5th August 2015 has recommended that the Nyamugasani focus in Kasese District be declared as transmission interrupted, and that intervention in that focus (including mass drug administration with ivermectin) be halted. Nyamugasani, therefore, becomes the 10th focus among the Uganda's 17 foci where transmission has been interrupted. This implies that a population of about 11.500 people in Nyamugasani has been protected from **Onchocerciasis** 

The UOEEAC also noted that Mt. Elgon foci (Mbale, Manafwa, Bududa, Sironko), Imaramagambo (Mitooma, Bushenyi) and Itwara (Kabarole, Kvenjojo) successfully completed post-treatment surveillance (PTS), a three-year monitoring period during which flies and blood samples from the formerly endemic areas are tested for evidence of River Blindness.

After three consecutive years with no sign of infection, final tests were conducted and analyzed. The results were discussed at the

UOEEAC which concluded that PTS was successful, and that the three foci are eligible for final evaluation.


Six other foci. Mnamba-Nkusi (Kibaale). Kashoya-Kitomi (Kamwenge,Ibanda Rubirizi, Buhweju) Wambabya-Rwamarongo (Hoima), Obongi (Moyo), Maracha-Terego (Maracha) , and Wadelai (Nebbi) are currently in their PTS periods. It is likely that next year, after three consecutive years with no evidence of river blindness, they too will be declared free of the disease and will undertake final evaluation.

Transmission of River Blindness is still ongoing in only two of Uganda's original 17 focus areas. The two foci where transmission is ongoing are the Madi-Mid North focus (Pader, Lamwo, Kitgum, Gulu, Amuru, Nwoya, Oyam, Lira, Adjumani, Moyo) of northern Uganda, and Lhubiriha in the Kasese District of western Uganda. Uganda and Sudan are the first nations in Africa to successfully approach the elimination of River Blindness with programs that primarily rely upon health education and biannual doses of Mectizan®, a safe and effective drug donated

Uganda's accomplishment is evidence enough that elimination of River Blindness is possible in Africa. At its peak, the disease affected 36 districts in Uganda, with about 4.9 million people at risk. Since 2007, when the President of the Republic of Uganda, His Excellency, President Yoweri Kaguta Museveni partnered with The Carter Center, Sightsavers, Lions Club, WHO/APOC and RTI/Envision in establishing a nationwide river blindness elimination program interruption of transmission has been achieved in most of the foci.

This latest success follows announcements made in 2012, 2013 and 2014 highlighting the first nine Ugandan foci to interrupt transmission. This implies that in 2015, more than 2.7 million Ugandans out of the original "at risk" total population of 4.9 million people in affected 36 districts of Uganda are now protected.

its attention to endemic areas bordering the Democratic Republic of Congo (DRC). Due to lack of information on the DRC areas bordering Uganda, mass drug administration continues in West Nile (Arua, Koboko, Yumbe), Nyagak-Bondo (Nebbi, Zombo), Lubiriha (Kasese) and Bwindi focus (Kanungu, Kisoro) areas



Similarly, Madi Mid-North, currently Uganda's largest focus, borders Republic of South Sudan and may also have cross border transmission.

This success has been made possible through the effort of the Ministry of Health's River Blindness Elimination Program with the support of implementing partners including The Carter Center, World Health Organization/African Program for Onchocerciasis Control, GTZ, Sightsavers, The Lions Clubs International Foundation, Merck, MDP, BASF, and RTI/Envision.
